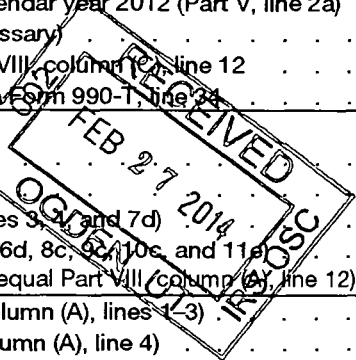

**More than 10,000 children are being served 5 days a week at 16 centers located in Kabul and other provinces in Afghanistan.**  
**During the current year, funding from Aschiana Foundation provided clothing, heating materials and blankets to help children and families through the winter, specific student educational support and general support of the Aschiana educational, vocational, food and health programs in order to assist the widespread population of children in need in Afghanistan.**

**The Aschiana Foundation partnered with American Medical Over Seas Relief to convert a wing of the Kabul Children's Center into a clinic to support the children and their families. Aschiana helps fund the operating costs of the clinic including the salary of a biomedical technician (trained in the US with and around Kabul.**
