KEUKA IS A PRIVATE, UNDERGRADUATE AND GRADUATE, RESIDENTIAL COLLEGE THAT ALSO OFFERS BACHELOR'S DEGREE COMPLETION AND MASTER'S DEGREE PROGRAMS THROUGH ITS ACCELERATED STUDIES FOR ADULTS PROGRAM (ASAP) AND INTERNATIONAL PROGRAMS IN CHINA AND VIETNAM. ENROLLMENT ON THE HOME CAMPUS AT THE ADVENT OF THE 2013-14 ACADEMIC YEAR WAS 1,769 THAT INCLUDES 885 IN ASAP REGARDLESS OF DEGREE OR LOCATION. KEUKA GRADUATES BOAST SIGNIFICANT, REAL-WORLD EXPERIENCE THAT IMPRESSES EMPLOYERS AND GRADUATE SCHOOLS AND THAT'S BECAUSE EXPERIENTIAL LEARNING HAS LONG BEEN THE CORNERSTONE OF THE KEUKA EXPERIENCE. KEUKA ALSO OFFERS SEVEN MASTER'S DEGREE PROGRAMS AND PRE-PROFESSIONAL PROGRAMS IN DENTISTRY, LAW, MEDICINE, VETERINARY MEDICINE, OPTOMETRY, PHARMACY, AND PHYSICAL THERAPY. COMMUNITY SERVICE HAS BEEN PART AND PARCEL OF THE KEUKA EXPERIENCE SINCE IT WAS FOUNDED AND TODAY, ALL OF THE 40-PLUS CLUBS ON THE HOME CAMPUS ARE REQUIRED TO CONDUCT AT LEAST ONE COMMUNITY SERVICE PROJECT EACH SEMESTER.
