The Foundation is organized and at all times shall be operated exclusively for the benefit of Francis Marion University and specifically to acquire, construct, finance, pledge, improve, maintain, operate, manage, and lease (1) housing facilities for students and faculty of the University (2) other real property and related personal property, (3) accept contributions and gifts for the furtherance of such purposes and the Foundation shall have no power to engage in activities not in furtherance of such purpose.

The Foundation as part of its mission to support the University is required to operate, maintain, and lease housing facilities for students and faculty. This program service is carried out through the Foundation's sole member FMU Student Housing, LLC. All revenue generated by the LLC from housing services are managed and held by the Foundation. Housing Services are provided primarily during the fall and spring semesters with minor revenues being received for summer semesters, fees and fines, and summer camp housing for FMU Summer Programs. Occupancy for fall was 99.42% or 1,530 of the available 1,539 beds while spring was 88.82% or 1,367 of the 1,539 beds available. Comparatively, fall was better than the previous year which had a 97.86% occupancy rate. Spring occupancy also was better than the previous year which had an occupancy of 87.26%. Expenses were directly related to operations of Housing Services. Property management is contracted out to the University which is paid \$135,000 for this service and reimbursed for all expenses related to this service of \$2,233,538. \$1,081,242 is attributable to interest on bonds issued in 2004 and 2006 for our Forest Villa Apartments. \$387,001 was rent paid to the University as part of the lease agreement between the LLC and the University to lease University owned housing. Lastly, \$551,865 was depreciation and amortization expenses of assets, bond costs, and leasehold costs of the LLC for its housing services. Remaining expenses were insurance and other miscellaneous costs.

4b (Code:) (Expenses \$ 449,417 including grants of \$ 0) (Revenue \$ 0)

The Foundation as part of its mission to support Francis Marion University periodically provides support in the form of direct cash contributions and non-cash contributions for the use by the University for operations and other needs as the University deems necessary to meet its mission and goals. During the year ending June 30, 2013, the Foundation paid \$449,417 of which notably \$37,691 was in support of the athletic complex construction, \$105,075 was for miscellaneous repair and renovation cost of the campus facilities and equipment, \$39,074 in vehicles, \$77,450 paid to the Education Foundation in support of the University, with the remainder being misc supplies, and contractual services paid on behalf of the University.

4c (Code:) (Expenses \$ 85,754 including grants of \$ 0) (Revenue \$ 17,469)

The Foundation as part of its mission to support Francis Marion University periodically acquires property with the intent of use by the Foundation or the University outside of the student Housing Services already provided. The Foundation acquired and held real property (not related to Student Housing Services) in January of 2013. A commercial property with preexisting leases was acquired which constitute the entire \$17,469 in revenue. As our intent in the acquisition of the property was not to use it as a rental property working with one of the leasee we were able to negotiate a lease buyout settlement for \$75,360 (includes legal closing cost) in May 2013. The remaining \$10,394 is attributable to property insurance, building depreciation, utilities, maintenance, and taxes associated with the property.

The Executive Director of the Foundation continually monitors transactions to ensure the Foundation's Bylaws and Controls are adhered to.
