SOON AFTER THE STORM WE WERE INVITED TO LEAD UPPER VALLEY STRONG, A TEAM OF APPROXIMATELY 50 NON-PROFIT AGENCIES, CHURCHES, SCHOOLS, TOWNS, AND LOCAL BRANCHES OF STATE GOVERNMENT. THIS ORGANIZATION WAS TASKED WITH ASSISTING AFFECTED RESIDENTS WITH THEIR HOUSING RECOVERY. OUR WORK THIS PAST YEAR INCLUDED CONTINUED LEADERSHIP OF THE UPPER VALLEY STRONG COLLABORATION AS WELL AS WORKING CLOSELY WITH STATE AND FEDERAL AGENCIES. AS OF THE END OF JUNE 2013 THIS WORK IS VIRTUALLY COMPLETE AND WE ARE NOW WORKING ON CREATING A STRATEGY FOR THE COMMUNITY TO DEVELOP RESILIENCE TO FUTURE EVENTS OF THIS TYPE.
