Alliance for Educational Justice: The Alliance for Educational Justice (AEJ) is a national alliance of twenty-six youth organizing and intergenerational groups working for education justice by organizing for non-punitive school reforms to advance student achievement.

In 2013, the Alliance for Educational Justice members have led community-based efforts to build restorative justice practices in school systems to address the achievement gap in 6 major cities impacting millions of youth: Chicago, Denver, Philadelphia, Baltimore, Los Angeles, and New York City. Through our Youth Justice Corps, we have trained over 300 youth from 11 cities in leadership, team-building and critical thinking skills to improve their education.

Brown Boi Project: The Brown Boi Project (BBP) is a community of masculine of center womyn, men, two-spirit people, transmen, and our allies committed to transforming our privilege of masculinity, gender, and race into tools for achieving Racial and Gender Justice. BBP works for Gender Justice by re-envisioning the power imbalance between traditional notions of masculinity and femininity. We hold institutional systems, other masculine people, and ourselves accountable for its accompanying privileges. We draw on a gender inclusive framework that shapes non-oppressive masculinity rooted in honor, community, and empowerment of feminine identified people, especially women and girls.
