Horse Rescue: This year, we pioneered an electronic record keeping system to record the health and behavior issues of each horse in the rescue group. We received the highest honors from the California Retirement Management Agency (CARMA), a leading horse rescue grant agency. We found homes for 3 horses and gave sanctuary to 3 more.

Lessons Program: We became the West Coast Flagship farm for HorseBoy Method Work, teaching and certifying 14 instructors, therapists, volunteers and parents in the HorseBoy Method for using horses to reach children on the autism spectrum. We have made presentations throughout Northern California about the work. We have given lessons to over 85 distinct individuals, generally providing approximately 30+ kids per week with 1-2 hours of genuine respite from taxing therapy schedules. We have provided a place where Everyone Fits and kids daily turn "I wish" into "I can".

Camps: We received a special commendation from the City of Half Moon Bay for our innovative and effective surfing and riding camp for special needs families. We provided over 30 families with respite. Many of these families have told us that this is their first "Break since having a special needs/autistic child.

Others are retrained to assist in an adaptive riding program for emotionally, physically or other disabled youth. Some of the horses can be neither retrained nor rehoused. Sanctuary is given to these horses. Due to the triple mission of the organization (with horses being a critical component for each), it is not possible to accurately break out the expenses by mission. Total program related expenses include horse care (\$39337) Ranch related costs (\$68662) and program related salaries (primarily instructors, trainers and horse care) \$68975 and auto (\$10,188).
