Organization received funds from the State of Iowa. 25% of the funds received are required to be placed in a permanent endowment. The balance is to be used for community projects in the Carroll County, Iowa area. Grants were made for various projects in Carroll County to enhance cultural, educational and development opportunities of the residents of Carroll County. Twenty-two grants were made in amounts between \$500 and \$12,500. The projects include providing for a community garden and playground equipment at local park, new scoreboard, children's books, basketball court at local park, tree planting, daycare remodeling and upgrade to equipment, assistance to restore an historical schoolhouse, building a playground, trail resurfacing, housing project sign and landscaping, upgrading stoves at a community center, building of a home for the poor, water safety class, funds to restore a historical church, funds for a local orchestra studio, environmental project and assistance to a community center.
