THE FOUNDATION DEVELOPS STRATEGIC PHILANTHROPIC PARTNERSHIPS WITH COMMUNITY STAKEHOLDERS TO RAISE MONEY IN SUPPORT OF SERVICESOURCE PROGRAMS THAT DIRECTLY IMPACT INDIVIDUALS WITH DISABILITIES. THE SERVICESOURCE FOUNDATION IS ALSO PLAYING A LEADING ROLE IN SUPPORTING SERVICESOURCE'S CAPITAL CAMPAIGN FOR THE NATIONAL CAPITAL AREA DISABILITY RESOURCE CENTER.
