The “Dairy Decisions Consultant” program continues to be beneficial to dairy farm families, with dozens of applicants in 2012. The majority of the producers using the program were interested in the feasibility of expansion or reinvestment in the industry. Others used the program as a “first step” to transition planning or to enhance future profitability of their dairy business.

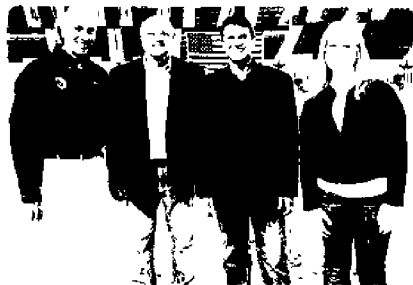


The center’s “On-Farm Resource Team” program, coordinated with the Penn State Extension Dairy Team, brought increased collaboration for better decision making to the dairy. Twenty-five new farms signed up for the program in 2012. Work on the “Transformation Team” project continued. Case studies from the ten participating farms will be made available in 2013.

In 2012, 1,000 producers learned more about their risk management options through the center. The center also continued to be a source of dairy market information and education for the industry.

Facilitating Transition In the Industry

Recognizing the critical role transition plays in the long-term viability of the dairy industry, the center developed resources to aid in dairy farm succession planning. The center hosted two “Building a Bridge to Dairy Transitions” workshops — one for 33 facilitators in May and one for 16 farm families in November. DairyLink , an online resource to connect dairy farm owners with young dairy entrepreneurs was introduced and is gaining in use.



The Center for Dairy Excellence hosted a day-long “Dairy Financial and Risk Management Conference” for 65 dairy lenders and financial planning consultants. The conference identified investment “Best Management Practices” on dairy farms and highlighted opportunity that exists within the Northeast dairy industry.



The center extends its appreciation to the Clark Family in Martinsburg and the Hoover Family in Lebanon for hosting this year’s tours, which drew 500 people.

Spurring the Conversations

2012 was the first year that the center became a full partner with the Professional Dairy Managers of PA in hosting the “Pennsylvania Dairy Summit.” More than 550 attended the two-day event, which included a one-day “Dairy Track” option new in 2012. Sponsorship support of this year’s summit was overwhelming.



The center continued to promote the value that Pennsylvania’s dairy farm families bring to the commonwealth. More than 35,000 copies of the center’s “Something to Treasure” brochure were distributed. Registrations to use “Discover Dairy” Lessons and associated resources grew by 25 percent this year. Countless visits were made with policy leaders and key influencers to share dairy’s story. The center also testified at two hearings about the industry.

The Dairy Powers Stakeholders continued to meet to identify opportunities and obstacles for increasing on-farm renewable energy production opportunities in PA.



With direction from the newly -formed Center for Dairy Excellence Foundation of Pennsylvania Board of Directors, the center introduced several new initiatives to shape the future of Pennsylvania’s dairy industry. The biggest initiative was the undertaking of the “Pennsylvania Dairy Futures Analysis” project, which looked at historical trends and future projections for production, processing and consumption of dairy in the commonwealth. The study will be released in early 2013.



Engaging the Next Generation

The center also introduced the “Dairy Leaders of Tomorrow” High School Dairy Track to provide students interested in dairy with a greater understanding of on-farm business management. Two lessons from the online curriculum were piloted by eight classrooms. The complete program will be available in early 2014.

Partnerships and collaboration continued to play a key role in the center’s work. In 2012, the center worked with the Professional Dairy Managers of PA and the Pennsylvania Dairymen’s Association to coordinate an on-farm internship program for eight college-level students. The internship gave the students an opportunity to gain on-farm experience, while exposing them to progressive dairy businesses in Pennsylvania and beyond.

The center also worked with the Dairymen’s Association to sponsor scholarships for young people interested in dairy. Seven college-aged students received \$1,000 academic scholarships,



while two young producers received scholarships to attend the Young Dairy Institute. More than 20 individuals received scholarships to attend the Pennsylvania Dairy Summit.
