Policy Advocacy and Movement Building:

Asylum Access continued to advocate for improved refugee right practices. Near the end of 2012, we succeed in finalizing a proposed amendment to Thai immigration law, which would keep Thailand's 142,000 refugees and asylum seekers safe from detention. Among other successes, we developed and pitched an urban refugee policy to the Tanzanian government. Officials are now stating publicly that they wish to develop a policy and would like us to implement legal aid programs once the refugee population is regularized.

Asylum Access is committed to advancing the global refugee rights movement. We have established an effective and sustainable model for change in Africa, Asia, and Latin America, and our advocates are continually expanding our reach and bringing our
