Unusual grants (Part II or Part III, line 1)

Public support revenue reported in Schedule A, Part II has declined annually since the fiscal year that started in 2008. During 2007 the NAUDL started 8 new urban debate leagues across the country. The NAUDL's financial reporting included public support and expenses of these leagues for a three-year start-up period. During the start-up period, NAUDL accepted contributions on behalf of these organizations as they secured their 501(c)(3) designations, hired professional staff, and established relationships with local school districts and other partner organizations in their local communities. Explanation

As the national leader of the urban debate movement, the National Association for Urban Debate Leagues (NAUDL) works with its partner leagues to provide debate programming to urban middle and high school students. In 2013, the NAUDL and its leagues served 7,301 urban debaters from 438 public schools in 19 cities across the United States. The NAUDL's primary goal arising out of our five-year strategic plan is to triple the number of urban students who participate in policy debate. Seventy-six % of our students are from low-income families and 87% are students of color. Each year, students address a pressing public policy topic. In 2013, urban debaters addressed the topic of transportation infrastructure issues from high speed rail to seaport security. Prior to that, they debated U.S. funding of space exploration. Urban debaters address contemporary public policy issues that impact their lives and futures. The urban public schools struggle with low test scores and high dropout rates. Currently, non-debating African American and Hispanic students in urban high schools have little more than 50% chance of graduating, but debaters are succeeding. Recent research by Briana Mezuk, PhD., demonstrates that 90% of debaters graduate on time from high school. High risk students show improvement in both academic and social measures from participation in debate. Debaters who graduate from high school are 89% more likely to advance to a 4-year college and of those who do advance to college, 80% are more likely to graduate. Debate prepares students for 21st Century careers. Urban debate teaches critical thinking and problem solving, communication and creativity, all skills that are essential in the 21st Century workplace. Debate inspires political engagement. As adults, debaters are more likely to vote, volunteer for a campaign or run for office. Each year, the NAUDL provides professional development for our league directors, provides grants to help support the leagues and hosts a National Championship tournament for our top performing students in each league. Students travel to Washington DC for three days of debate competition and educational programming. By providing competitive opportunities through urban debate, we encourage young debaters to set their sights on college and career success and we help our students learn to build the resilience and grit they will need to achieve their goals in school, careers and life.
