The Educational program includes social, health and nutrition services that support the total education of the student. In addition, the educational services include regular, as well as special education instruction. Foundation Academy Charter School promotes the full involvement of parents in their children's educational development. The Charter School completed the 2012-2013 school year with an enrollment of 225 students in its Middle School, which students were enrolled in nine classes of twenty-five each. In addition, 118 high school students were enrolled in grades 9 thru 11.
