**Spiritual Life and Community Service**

The Chapel is open daily for all those who seek refuge for peaceful reflection and prayer. The Chaplain's Office strives to promote faith development, personal reflection, and religious understanding through a range of programs and services. A Chaplain's Advisory Committee meets regularly to assist the Chaplain in the planning of religious programming for the community, and the Endicott Christian Fellowship group meets weekly to explore a portion of the Bible and its impact on everyday life. Other groups and events include Cornerstone, a community of campus Christians exploring or desiring to deepen their Christian identity, and Sanctuary, a monthly mass/chapel service. Interfaith services are also offered. The Endicott College Community Service program is affiliated with the Chapel, and many activities are co-sponsored. Volunteer programs include Relay for Life, Alternative Spring Break, Community service projects, and community service learning. During the year, the Endicott community contributed over 19,000 community service hours to local organizations.
