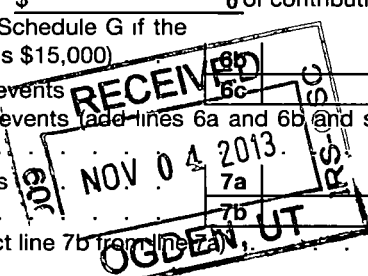

**990-EZ Part 1 #10 - \$16,000 was paid out in grants to Kent Intermediate School District (2930 Knapp Street, NE, Grand Rapids, MI 49525). \$15,000 was for the early childhood program to support home visiting services for families with young children. The remaining \$1,000 was to help defray costs associated with the Spelling Bee for children in grades four through eight. The remaining \$6,856 were grant fund expenditures under \$5,000.**

**990-EZ Part 1 #16 - Other expenses totaled \$28,638. The majority of these expenses were for meeting expenses, including room rentals, meals, lodging for retreats, entrance fees, etc. This includes meetings for the Kent Intermediate Superintendents' Association, Kent Intermediate Association of School Boards, Cambridge Leadership Academy, Kent Learning Collaborative, and Interfaith Student Leadership. There was also a \$20 expense included for the Nonprofit Corporation Filing Fee and \$787 spent on various memorial contributions and recognitions.**

**990-EZ Part III #31 - The "other program services" included \$9,182 spent for the leadership development and advancement of the Kent Intermediate Superintendents' Association which includes the lead administrators in Kent County's 20 local school districts working toward transformational change for the 130,000 students in Kent County. \$8,095 were spent on educating board members, administrators and students in Kent County on the ill effects on students of bullying and how simple acts of kindness can sustain a culture of compassion. \$6,450 were paid out as grants (scholarships) for five board members from local Kent County school districts to attend the Federal Relations Network Conference in Washington, DC. The Kent Intermediate Association of School Boards which lead education improvement throughout the Kent Intermediate School District that affects approximately 130,000 children in Kent County spent an additional \$1,721 on meeting expenses including meals, copies, and room charges. \$2,848 were spent on meetings for Kent Learning Collaborative which is a group of administrators working collaboratively to keep curriculum in school districts updated for the children in Kent County and \$1,000 was given to Kent Intermediate School District to help defray costs associated with the Spelling Bee for children in grades four through eight.**
