In the past year we have added three new staff to our team, including a new Director of Prevention, and our prevention team ministered to 212 children between our fall, spring, and summer programming We have expanded our outreach territory by moving into a new area on our Friday night outreach and adding an additional day of outreach This year, we were welcomed into 3 new clubs, two of which we have previously not had favor We have also added a second care team line to increase the number of individuals our care team is able to follow-up with The Care Team followed up with 139 individuals, started a support group for women, and celebrated one baptism and one college graduation

In August 2012, the new NightLight Los Angeles Director was sent out to relaunch the LA Office That November, the LA office hired a staff member to expand development For the year, the LA office has been fundraising and strategic planning for the official launch at the end of September

Between July 2012 and June 2013, NightLight in Bangkok provided alternative employment, vocational training, spiritual development, meals, health care, and life-skills training to an average of 50 women who were exiting or at risk of exploitation in the sex industry As part of their support, NightLight provided childcare for an average of 18 children under the age of 5 and tuition scholarship to 38 children NightLight makes contact with several hundred women in prostitution and trafficking each year and offers assistance and intervention Eighteen international trafficked victims were assisted and eight were repatriated during the fiscal year A shelter has been set up for victims of trafficking and sexual exploitation to be fully operational in the last quarter of 2013 NightLight also addresses the demand side through activities in the outreach center Progress has been made in the building and set up of a coffee shop in the red light area to target the demand side as well as the broader community of those affected by the sex industry NightLight also does prevention work in the northeast of Thailand to address the supply of young women into the sex trade On the streets of Bangkok, NightLight reaches out to and provides assistance to the children who beg, vend, and are at high risk of trafficking NightLight actively does awareness-raising to an average of 600 visitors per year and through trainings, speeches, and media that reaches a global audience NightLight partners with many other NGOs and government organizations to combat trafficking through investigation, intervention, assistance, shelter, and repatriation

With its launch in October 2012, the NightLight Branson location has already made significant strides in establishing a presence and ministry in the Branson/Springfield area In the first several months of its existence the location has focused on building a ministry team of staff and volunteers, connecting with key people, resources, churches, and ministnes in Branson and Springfield, and launching a club outreach program
