Pride Academy Charter School commenced implementation in the 2008-2009 school year and has just completed its fifth year of operation. The school's charter authorized a maximum enrollment of 240 students in Grades 5-8. During the first charter renewal, Pride Academy sought and obtained approval for increased enrollment to 264 students. The enrollment at the beginning of the school year was 264 students. At the end of the year the enrollment was 260 students. There are three classes each of Grades 5, 6, 7, and 8, with class sizes of 22 students per class. As of July 31, 2013, there were 272 students on the waiting list. During the 2012-2013 school year, the Charter School's Administrative team continued to lead the growth and strengthening of the school in the fifth year of operation. Of the many accomplishments of the charter school was the continued development and implementation of an elective and after school program that offers a wide range of athletic, academic, and culturally enriching activities and experiences that included Student Council, yearbook, cheerleading, basketball, soccer, flag football, African Dancing, MVP male empowerment, cooking, chorus, multicultural clubs and book clubs
