The contract entitles the School to receive on a monthly basis the amount, if any, by which a floating rate exceeds the fixed rate or to pay the amount, if any, by which the floating rate falls below the fixed rate of 4.035 percent of the notional amount. The floating rate is tied to the SIFMA Municipal Swap Index rate. The original notional amount of the contract was \$17,557,600 and declines on a monthly basis over the term of the agreement through August 1, 2017. The notional amount is set at 75 percent of the new debt issued. The School has valued the interest-rate swap contract at fair value. The fair value of the interest-rate swap contract at June 30, 2013 and 2012 were liabilities in the amount of \$2,067,783 and \$2,643,755, respectively, as determined by Sovereign Bank, N.A. utilizing forward interest rate estimates and present value techniques and is included in liability under interest-rate swap contract on the statement of financial position. The change in fair value for the years ended June 30, 2013 and 2012 represents a gain in the amount of \$575,972 and a loss in the amount of \$556,237, respectively, which is reflected on the statement of activities and changes in net assets.
