# **CATHOLIC YOUTH ORGANIZATION (CYO) OF MERCER COUNTY**

## **Organizational Policies and Procedures**

### **990 Review Policy**

CYO's completed Form 990, including significant schedules, is presented to the Finance Committee of the Board of Trustees for their review prior to its submission to the Internal Revenue Service.

### **Compensation Determination Policy**

When hiring the Executive Director and other key employees, the Finance Committee of CYO's Board of Trustees will perform a thorough review to determine suitable compensation. This process is to include a review of comparability data, which can include compensation surveys, written employment contracts and 990s of similar organizations. The Committee will make a full report of the deliberation and final decision to CYO's Board of Trustees.

### **Conflict of Interest Policy**

Members of CYO's Board of Trustees should uphold CYO's goal of establishing and maintaining the highest level of public confidence in its accountability. With respect to potential conflicts of interest, they should be committed to the following standards:

Conduct activities with CYO's Board of Trustees so as not to advance or protect personal interests, or the private interests of others with whom they have a relationship, in a way that is detrimental to the interests of or to the fundamental mission of the CYO.

In every instance in which they represent the CYO, conduct activities in a manner to best promote the interests of the CYO.

In all matters that come before the Board of Trustees for a vote that may favorably impact their own financial interests, or the private interests of others with whom they have a financial relationship, they will reveal that relationship and abstain from a vote in the matter.

When a conflict of interest arises, or when a potential conflict of interest emerges, they will disclose that conflict or potential conflict to CYO's Executive Director or to the Chairman of its Board of Trustees and seek a resolution of that issue.

Each member of CYO's Board of Trustees is expected to personally commit to these standards, in writing, by signing CYO's Conflict of Interest Statement, a template of which is attached. These signed statements are maintained on file with other CYO Board records.

### **Document Retention and Destruction Policy**

CYO follows the document retention procedures outlined below.

### **Public Disclosure Policy**

CYO's governing documents, conflict of interest policy, Form 990, and financial statements are available to the public upon request. Requests in-person or those received by written, phone, fax or e-mail means will be honored within five business days of the request. CYO reserves the right to charge a reasonable copying fee plus actual postage for multiple copies requested from the same individual or related group of individuals.

### **Whistleblower Policy**

This policy is intended to encourage CYO board members, staff (paid and volunteer) and others to report suspected or actual occurrence(s) of illegal, unethical or inappropriate events (behaviors or practices) without retribution.

1. The whistleblower should promptly report the suspected or actual event to his/her supervisor.
2. If the whistleblower is uncomfortable or otherwise reluctant to report to his/her supervisor, the whistleblower should report the event to the next highest or another level of management.
3. The whistleblower can report the event with his/her identity or anonymously.
4. The whistleblower shall receive no retaliation or retribution for a report that was provided in good faith – that was not done primarily with malice to damage another or the organization.
5. A whistleblower who makes a report that is not done in good faith is subject to discipline, including termination of the Board or employee relationship, or other legal means to protect the reputation of the organization and members of its Board and staff.
6. Anyone who retaliates against the whistleblower (who reported an event in good faith) will be subject to discipline, including termination of Board or employee status.
7. Supervisors, managers and/or Board members who receive the reports must promptly act to investigate and/or resolve the issue.
8. The whistleblower shall receive a report regarding the investigation, disposition or resolution of the issue.
9. The identity of the whistleblower, if known, shall remain confidential to those persons directly involved in applying this policy, unless the issue requires investigation by law enforcement, in which case members of the organization are subject to subpoena.
