Human Service Expense In fiscal year 2013, Two Ten Footwear Foundation funded 1,797 families who work in the footwear industry with emergency assistance during times of pressing need The population we serve is vulnerable to loss of income due to unexpected decreases in working hours when a retail store business slows or orders in a factory or warehouse decrease The most cited reason for calling Two Ten for assistance is due to employment issues, followed by natural disasters and family issues In order to receive financial assistance individuals must work for two years in the industry (during natural disasters the eligibility requirement is lowered to one year) The majority of funds were paid directly to creditors to cover utility payments, oil bills, rent, mortgage, car payments, car repairs, funerals, and in some cases critical medical bills In total, 783 families received financial assistance with their rental or mortgage payments, 255 families with car payments or essential car repairs, 466 with utilities, 632 with financial help to recover from natural disasters including hurricanes, tornadoes, floods or fire, or a death to an immediate family member In addition to funds sent to creditors, Some mini-grants between \$100 - \$1,500 were paid to individuals impacted by natural disasters, fires and crises that require immediate cash \$291,100 was spent to assist Super Storm Sandy victims during fiscal year 2013 Individuals impacted by natural disasters used Two Ten funds to purchase hotel stays, generators, food, gasoline, clothing and other urgent necessities The majority of footwear workers who call Two Ten for help primarily fall into two segments retail workers who work at large chain stores selling footwear, or manual laborers working in manufacturing or warehouse operations of footwear companies 70% of those who contacted us were women, one third of whom are between the ages of 25 and 34 The top three states we received calls from in fiscal year 2013 were New York, New Jersey, and Tennessee Besides covering basic necessities, Two Ten also provides counseling services and information referral services Two Ten contracts with FEI Behavioral Health to administer telephonic counseling services Each individual who calls receives 8 telephonic counseling sessions 46 individuals in 2013 received counseling referrals, 894 individuals received information referral services Anyone who works in the footwear industry for any length of time is eligible to receive counseling and information referral services Information referrals are given to provide additional resources outside of Two Ten that can offer individuals assistance such as food pantries, heating fuel assistance, legal aid and United Way Education Expense In 2013, Two Ten Footwear Foundation funded 350 individuals from the footwear industry and/or footwear families with annual scholarships of approximately \$2,500 each Scholarships are given based on financial need as measured by the EFC (estimated family contribution) of each student In order to be eligible to receive a scholarship, an individual or their parent must have worked at least two years in the footwear industry Scholars must have at least a 2.5 GPA and be enrolled in or about to be enrolled in an accredited two or four-year college, university, vocational/technical school or nursing school Every year, a small percentage of students are funded to attend school for footwear design Unlike our traditional college scholarships, the Footwear Design Scholarship is available to any student without any eligibility requirement of working in the footwear industry This scholarship is to assist students who are studying design with a focus on footwear The program was created in 2003 to assist students with a demonstrated interest and skill in pursuing a career in footwear design Students are evaluated on design talent, in addition to financial and academic criteria, and are evaluated by submitting three design samples in addition to completing the standard online application In 2012, the application administration process was outsourced to International Scholarship and Tuition Services, who oversees the online application process Two Ten scholarship staff rank applicants using a scoring rubric that is weighted by the following system 70% financial need, 15% academic performance based on gap, 15% academic resume based on extracurricular activities

MEMBER AND EDUCATIONTwo Ten Footwear Foundation is committed to building a stronger footwear community by offering a series of four national programs, geared toward specific audiences The Women in Footwear Industry (WIFI) group is focused on inspiring, mentoring, and educating women at all levels of their careers In fiscal year 2013, WIFI held 12 networking and professional development events in locations across the US that were attended by 825 women The Young Professionals (YP) for 210 group is designed to attract the footwear professionals by providing relevant content and networking opportunities In FY13, YP210 held two events that engaged 325 people The third program, the HR Leadership Committee, is built for human resources professionals within the footwear industry to network with peers and business professionals dedicated to learning and innovation, as well as supporting the footwear industry and its people Each year, the committee hosts a conference called the HR Leadership Summit that is attended by 200 industry professionals The final program was launched in FY13, through Footwear Cares Two Ten united 68 footwear companies and over 3,000 footwear volunteers across the country in a first-ever, industry-wide community service program to help local charities serving families and communities

LEADERSHIP DEVELOPMENTFounded in 1939, Two Ten is the footwear industry’s national charitable foundation the only foundation of its kind in the United States To increase awareness of the Foundations offerings within the industry it serves, Two Tens FY13 outreach efforts included 28 corporate visits with presentations made to 3,722 American footwear workers The Foundation also attended 7 different benefit fairs to connect directly with industry employees Part of the Leadership development is to do outreach to support the footwear industry facing difficulty, the Foundation relied upon integrated material to reach a wider client base of prospective users of our programs and services We shared client profiles to demonstrate the Foundations impact within the footwear industry To accomplish this, Two Ten supplemented its budget spend with barter agreements, pro-bono work, and gifts in kind from partners and supporting companies
