Shelter Program: In the 2013 Fiscal Year, the shelter program housed 174 individuals for a total of 7,392 bed nights. Of those clients that left the program, 54 individuals were able to move to permanent housing without the assistance of a subsidy. An additional 15 clients moved in with family or friends and 23 clients were able to find placement in a transitional housing program. Of those clients that left the shelter program, 116 were able to secure part time or full time employment. Shelter staff also received 384 calls requesting information on shelter availability.

4b (Code) (Expenses \$ **220,821** including grants of \$) (Revenue \$)

Harvest Homes: In the 2013 Fiscal Year, the Harvest Homes program provided housing for 13 families which consisted of 22 adults and 26 children as well as an additional 23 individuals. The Harvest Homes program provided 11,435 bed nights to those individuals and families that would have otherwise been homeless.

4c (Code) (Expenses \$ **59,521** including grants of \$) (Revenue \$)

Outreach: In the 2013 Fiscal Year, the WARM Center outreach program was able to serve 289 households. This consisted of 435 adults and 326 children. In total, WARM Center distributed more than \$50,000 to these families and individuals in the form of financial assistance for rent, utilities, hotel/motel vouchers, and prescriptions.
