ADTI Housing Corp is a subsidiary of Alternatives, Inc , a NJ Not-For-Profit Corporation, dedicated to the creation of affordable housing for Alternatives', Inc 's consumers with special needs as well as low/moderate income people from the general public The staff of housing development and financial professionals specializes in the creation of affordable housing units for those most in need of safe and decent homes During Fiscal Year 2013, ADTI Housing Corp provided property and facilities management services to over 150 agency-owned special needs and affordable housing units throughout Central New Jersey In addition, ADTI acted as the authorized agent for over 80 properties leased by Alternatives, Inc , the parent company, to provide housing to individuals with special needs ADTI Housing Corp was approved as a Qualified Housing Developer by New Jersey Housing Mortgage and Finance Agency (HMFA) for the Special Needs Housing Partnership Loan Program (SNHPLP), and it experienced an increase in capital through grant writing activities for the creation and maintenance of agency-owned projects ADTI secured \$117,620 in HOME Investment Partnership funds to expand the Franklin House Transitional Housing Program, in Somerset County, to provide transitional housing to formerly homeless families It also received a commitment for \$50,000, from the Somerset County Homeless Prevention Funds, to rehabilitate permanent housing for the homeless Furthermore, Franklin Township earmarked \$250,000 in Affordable Housing Trust Funds for the development of a new 4-person group home in their municipality through a partnership with ADTI, Franklin Township and the State's Special Needs Housing Partnership Loan Program A new site for another 4-person group home was identified in the Township of Alexandria, Hunterdon County, and a rental property in West Long Branch, Ocean County, was secured for the operation of an additional 4-person group home The agency wrapped up a substantial rehabilitation to one of its group homes for three (3) individuals with special needs located in the Township of South Boundbrook, and added an additional bath for the benefit of former homeless families who reside at the Franklin House Transitional Housing Program in Somerset County The second phase of the accessibility improvements at the Administrative Office was also completed The Agency satisfactorily passed nine (9) management reviews of its HUD-811 projects as well as other monitoring inspections by the Somerset County Community Development Office and the New Jersey Department of Community Affairs
