Community Action and Development ProgramsIn every county in New Jersey, the State designates official Community Action Agencies (CAA) In 2009, the Jewish Renaissance Foundation, Inc (the “Organization”) was designated by the State as the official CAA for Middlesex County East Although most Organization programs continue to benefit residents throughout Middlesex County, its state-funded CAA programs are provided specifically for qualified residents in eight designated communities Carteret, Edison, Highland Park, Metuchen, Perth Amboy, Sayreville, South Amboy and Woodbridge As a CAA, the Organization helps qualified people attain economic self-sufficiency The Organization also provides emergency services to meet immediate needs, while fostering individual growth and transition to household stability Qualifying households in need of emergency assistance can obtain help through the following four programs food assistance, rent/mortgage assistance one time in a fiscal year for households with at least two months behind in rent or mortgage with the capacity to meet minimum payment of \$25 toward the debt before assistance and able to demonstrate an ability to pay independently going forward, and utilities assistance during the months of June through October for households who received a shut-off notice from the utility company, or be more than \$500 in arrears on utility payments, and able to demonstrate an ability to pay going forward Through collaboration, consortiums and alliances, the Organization also demonstrates its commitment to community development specifically for the “Greater Budapest” neighborhood With a comprehensive neighborhood revitalization plan (the “Plan”) put together by various community stakeholders, the Organization is committed to implementing the Plan which included the following main components (1)Create a sense of place and foster community engagement, (2)Develop affordable housing, (3) Ensure better access to social services, especially medical health services, (4) Increase after-school activities and create better recreational opportunities, (5) Create economic opportunity, (6) Provide job training for youth and adults, (7) Make improvements to the Amboy Avenue business district, (8)Provide assistance to existing businesses and to those who wish to be entrepreneurs, (9) Ensure public safety, and (10) Park and Recreation improvement Community action and development programs are funded through federal, state and community grants and contributions

The topic was focused on family since July was family Reunion Month 8-9 CJC Olympics - Students and staff participated in sports events and then had a celebratory BBQ 8-29 HIV Workshop - Group 7 students were educated on STDs and had HIV Screenings JRF participated in several community service projects 7-25 Distributed flyers for the PAAC Program7-25, 8-30 and 9-12 Volunteered at the Alameda Nursing HomeGroup 8 participated in a 4 week independent cooking series at Eljahs Promise The students learned different meal options when living on their own The 7th group of Civic Justice Corp (CJC) students completed program on 7-26-12 8 students completed the program and 2 of them received their GED CJC brought in a new group of 12 students on November 2, 2012 This represents our 9th group Perth Amboy and Carteret were hit hard by Super Storm Sandy and many of our students were affected JRF staff including CJC staff responded to their needs providing food cards, transportation, and baby items On 10-10 the students from Group 7 attended the Greater Plainfield Habitat for Humanities ground breaking ceremony On 10-10 Group 7 also participated in a financial literacy/credit building workshop presented by the Intersect Fund CJC celebrated Hispanic Heritage Month on 10-11 & 12 All the students participated making Vejigante masks and learning Spanish dancing They also feasted on amazing Spanish food JRF participated in several community service projects 7-25 Distributed flyers for the PAAC Program10-25, 11-7, 11-28, and 12-10 Volunteered at the Alameda Nursing Home11-21 Baked cookies and brownies for the Olive Street Thanksgiving Dinners for the homeless 12-4 Cooked dinner for the Salvation Army for the homeless HIV Workshop 11-14 - Group 8 students were educated on STDs and had HIV ScreeningsCJC celebrated Thanksgiving with our annual dinner The focus was what we were thankful and grateful for CJC students went on a tour of the Raritan Bay Medical Center to explore all the possible careers in the medical field CJC started an after program hours basketball league which is open to the residents of the Budapest neighborhood The league is home to 8 teams of 8 players Games are held on Wednesdays and Fridays and will runs through February On 1-10-13 a representative from Everest Institute came to speak to the students about the programs they offer and how to access proprietary education CJC brought in a contractor on 1-15 and 1-16-13 - RMB Safety to administer the OSHA 10 hour certification to the students 10 students received their OSHA certification AWE sponsored the first Employment Boot Camp on 1-28-13 This workshop was designed to help job seekers with their job search On 1-30-13 CJC students assisted in the Middlesex County Homeless Connect project They helped volunteers survey the homeless population and provide resources On 2-12-13 AWE sponsored an entrepreneurial workshop “Create Income for Yourself” This workshop focused on using what you know to generate extra income On 2-17-13 a representative from the Perth Amboy Police Department Officer Jay Martinez came in to speak to the students about police/community relations CJC took the students on 2-19-13 to visit Mobile Tech Institute to learn about the programs they offer The school specializes in professions relating to automotive with the exception of mechanic Out of the 12 students that were brought in from Group #9 - 7 of them received their GED On 2-21-13 the students from Group #8 and #9 attended an afternoon presentation given by Jay Morrison, Project Culture Change He spoke to the students about his experiences and how to move forward regardless of their pasts We also invited Youth Corps from New Brunswick to participate as well CJC partnered with Project Culture Change to sponsor an overnight for young men on 2-23-13 The students were exposed to mentors and programming to help them make better choices AWE sponsored the 2nd Employment Boot Camp on 2-25-13 This workshop focused on getting to know your strengths and weaknesses On 3-4-13 the students from Group #8 and #9 completed an all-day work ethics training The training is a full day and focuses on how to conduct yourself on the job The 8th group of Civic Justice Corp (CJC) students completed program on 3-7-13 7 students completed the program and 4 of them received their GED CJC brought in a new group of 12 students on 3-11-13 This represents our 10th group So far, 2 students have already passed their GED AWE sponsored the 3rd Employment Boot Camp 3-18-13 This workshop focused on using social media to get hired quickly We participated in several community service projects 3-12 and 3-19-13 Volunteered at the Alameda Nursing Home3-13-13 CJC students flyered Perth Amboy to help the Family Success Center promote and event On 4-10-13 Group #9 and #10 participated in the “True Colors” exercise which was facilitated by Linda Rivera for the Office of Faith Based Initiatives On 4-17-13 the students of Groups #9 and #10 participated in a mentoring program with the Sancophoa League and then following they were able to have fun in a friendly but competitive basketball game CJC students and staff celebrated Earth Day on 4-22-13 by cleaning up the areas outside of our program and planting flowers and plants The students were working on making picnic tables and flower boxes in their vocational program These projects were completed and the amazing products are displayed out on our patio Following all the work there was a celebratory BBQ AWE sponsored the 4th Employment Boot Camp on 4-23-13 This workshop focused on interviewing skills and included mock interviews and feedback CJC students from both groups participated in a Earth Day clean-up of the park across the street from where program is held on 4-25-13, Dalton Park CJC students who were interested participated in a college tour of Middlesex County College on 5-10-13 5 students toured the campus On 5-28-13 AWE sponsored the 4th Employment Boot Camp This workshop focused on helping job seekers stand out with their resume We provided an interactive forum to help those revise their resumes Our 9th group of Civic Justice Corp (CJC) students completed program on 5-30-13 Although only 3 students completed the program, 7 of the 12 that started received their GED On 6-4-13 UMDNJ came in to provide an STD workshop for the students They were able to be tested for HIV if they so choose Lenny Williams from NJIT came to speak to the students on 6-11-13 on the opportunities available to them through NJIT On 6-17-13 AWE sponsored and Entrepreneurial Support workshop to help those thinking of starting a business We provided a representative from the Intersect fund explain and navigate how to access funds CJC students once again cleaned up Dalton Park on 6-18-13
