The students are afforded educational opportunities through the implementation of various instructional ideologies that are aligned with the New Jersey Core Curriculum Content Standards. In addition, the comprehensive curriculum is complemented with the teaching of music and violin tutorial opportunities are provided on a daily basis for individuals and small groups. Clear, student-centered goals focused on staff professional development has resulted in significant gains in achievement during the 2012-2013 school academic year. Communications to parents are offered through regular parent-teacher conferences, the Parent Academy Program and monthly meetings. The Charter School completed the 2012-2013 school year with the enrollment of 274 students.

It also made continued significant progress in the following major initiatives based upon a school-wide assessment by parents and staff in order for our village to continue to achieve high levels of excellence: 1) Improve Student Achievement, 2) Build Organizational Capacity, and 3) Broaden the base of Community Partnerships. The same areas will remain priorities for the upcoming school year.

 The Charter School provided nutritionally balanced, low cost or free meals to children each school day through its Breakfast and Lunch Programs. The Programs are federally and state assisted.
