	THE CARLISLE AREA HEALTH & WELLNESS FOUNDATION ("FOUNDATION") PROVIDES FUNDING FOR GRANTS AND INITIATIVES THAT SEEK TO IMPROVE INDIVIDUALS' HEALTH STATUS AND BUILD COMMUNITY HEALTH CAPACITY. THE FOUNDATION'S CENTRAL PURPOSE IS TO PROVIDE SUPPORT TO PROGRAMS ALIGNING WITH FIVE BOARD-ADOPTED FOCUS AREAS TOWARD THAT GOAL IN 2012-13 THE TOTAL GIVING TO RESPONSIVE GRANTS WAS \$1,949,749, RELATED PERCENTAGES FOR THE FOCUS AREAS WERE PRIMARY CARE-40%, ORAL HEALTH-20%, BEHAVIORAL HEALTH-18%, NUTRITION, PHYSICAL ACTIVITY AND TOBACCO CESSATION-16%, AND ALLIED HEALTHCARE EDUCATION-6%. GRANTS WERE PROVIDED TO 25 NONPROFIT ORGANIZATIONS. ADDITIONALLY, BEYOND RESPONSIVE GRANT MAKING THE FOUNDATION DEVELOPS INITIATIVES TO PROACTIVELY ADDRESS PRIORITY GOALS. THE TOTAL FUNDING FOR 2012-13 OF \$78,741 SUPPORTED SUCH EFFORTS AS WELLNESS AT WORK AND 5210, A HEALTH PROMOTION CAMPAIGN TO INCREASE HEALTHY EATING AND ACTIVE LIVING. SIX PROGRAMS AT SADLER HEALTH CENTER ARE SO CRITICAL TO THE FOUNDATION'S MISSION AND THE COMMUNITY'S BASIC HEALTHCARE NEEDS THAT IN TOTAL THEY RECEIVED APPROXIMATELY 65% OF GRANT FUNDS. THE SERVICES OFFERED THROUGH THIS COMMUNITY HEALTH CENTER INCLUDE TRADITIONAL MEDICAL AND DENTAL CARE, HEALTHY RX, WHICH HAS SECURED OVER \$23 MILLION IN FREE PRESCRIPTIONS IN JUST OVER SEVEN YEARS, TOBACCO CESSATION, WITH A HIGHLY SUCCESSFUL 65% QUIT RATE, NURSE-FAMILY PARTNERSHIP, A NATIONALLY RESPECTED EVIDENCE-BASED PROGRAM, AND BEHAVIORAL HEALTH COUNSELING. IN THE STATEMENT OF FUNCTIONAL EXPENSES, THE FOUNDATION REPORTS THAT 79% OF ITS FUNDS SUPPORTED PROGRAM SERVICES IN 2012-13. ON AVERAGE, A GRANT LEVERAGES OVER \$3.00 FROM OTHER RESOURCES FOR EVERY \$1.00 THE FOUNDATION INVESTS. BEYOND TRADITIONAL GRANT MAKING, THE FOUNDATION ASSESSES COMMUNITY HEALTH NEEDS THROUGH ROUNDTABLE DISCUSSIONS AND SURVEYS, BUILDS NONPROFIT CAPACITY THROUGH REGIONAL TRAININGS ON TOPICS SUCH AS FUNDRAISING, MEDIA RELATIONS, AND OUTCOMES MEASUREMENTS, EDUCATES THE PUBLIC ABOUT, AND ADVOCATES FOR, STRONG HEALTH POLICIES, DRIVES COLLABORATION BY LEADING REGIONAL PARTNERSHIPS SUCH AS THE CUMBERLAND COUNTY STATE HEALTH IMPROVEMENT PARTNERSHIP AND A YOUTH NUTRITION AND ACTIVITY COALITION, AND PROACTIVELY DEVELOPS EVIDENCE-BASED INITIATIVES, SUCH AS A 5210 HEALTH CAMPAIGN AND RELATED GRANTS TO AREA SCHOOLS.
