THE HILL SCHOOL PROVIDES A CHALLENGING CURRICULUM TO ITS 512 STUDENTS EMPHASIZING CRITICAL THINKING AND WRITING. A TOTAL OF 24 ADVANCED PLACEMENT COURSES WERE OFFERED AS WELL AS AN ARRAY OF HONORS CLASSES AND INDEPENDENT STUDIES. IN 2013, 191 STUDENTS TOOK 411 ADVANCED PLACEMENT EXAMS. HILL STUDENTS ARE ACTIVE IN ATHLETICS, THE ARTS, STUDENT-RUN ORGANIZATIONS AND COMMUNITY SERVICE. HILL STUDENTS ARE DRAWN FROM 29 STATES AND 25 FOREIGN COUNTRIES. THE TYPICAL CLASS SIZE IS 12-14 STUDENTS WITH A STUDENT/TEACHER RATIO OF 7:1.
