Residence Requirement - As a condition of employment the President, the Dean of Students & Vice-President Development & Alumni Relations maintained their full time residence in College-provided housing and used the residence for College business and entertainment purposes. Social club dues - Membership dues were provided to three New York University clubs to be used primarily for business purposes (entertainment / travel).
