THE WRIGHT CENTER FOR GRADUATE MEDICAL EDUCATION (WCGME) IS A COMMUNITY-BASED GRADUATE MEDICAL EDUCATION CONSORTIUM OFFERING TRAINING PROGRAMS FOR PRIMARY CARE INTERNAL MEDICINE RESIDENTS AND CARDIOLOGY FELLOWS THROUGH AFFILIATIONS WITH HOSPITALS, THE REGIONAL VETERANS AFFAIRS HOSPITAL (VA) AND FEDERALLY QUALIFIED HEALTH CENTERS IN NORTHEAST PENNSYLVANIA. RESIDENTS AND FELLOWS ARE TRAINED IN SEPARATE THREE-YEAR PROGRAMS APPROVED BY THE ACCREDITATION COUNCIL FOR GRADUATE MEDICAL EDUCATION AND THE AMERICAN OSTEOPATHIC ASSOCIATION.
