Family Based Activities/Programs

Parent Network, is a program designed to offer guidance, support, and initiatives aimed at nurturing more open communication between parents and children. This will take the form of discussion forums, social opportunities, educational programs, communication channels, resources and guidelines, to name a few, aimed at helping parents and youth to better understand and interact with each other and to help improve family management skills and enhance youth/parent relations. Activities include *Parent rap*, *Central Bucks TV*, *Backpack Newsflash* and a parent resource binder. Programs benefit approximately 16,059 families in Central Bucks area.

Community Based Activities/Programs

Volunteer Connections is a program that organizes local service projects through an interactive database in partnership with 29 organizations. Activities include MLK Day of Service, which organizes local service projects. Program benefits approximately 2,772 community members.

Individual Based Activities/Programs

Youth Activities is a program that empowers youth to participate in productive and constructive activities designed to keep youth away from risky behaviors. Activities include *Youth to Community Art Series (Y2C)* providing Central Bucks youth with an opportunity to showcase their dedication and devotion to the arts. Youth Activities program benefits approximately 1080 community members and 186 youth.

School Based Activities/Programs

Community Connections, is a program that helps to build awareness among our youth of the need for and importance of making healthy choices every day. CB Cares Educational Foundation links schools in Central Bucks with community organizations that provide assembly programs and services addressing health and educational related issues that support the Central Bucks School District curriculum. Activities include Mini Grant Program - a granting initiative offered to the Central Bucks Schools to host programs or assemblies that focus on youth related issues, youth risk factors, violence prevention, family relationships and bonding, community service learning, diversity acceptance and healthy relationships. ATOD awareness programs aimed at seniors prior to the prom or graduation involving messages regarding alcohol awareness and delivered by several media outlets.
