They analyze prior year numbers along with the proposed budget provided by the finance committee to arrive at a number that is comfortable for the organization. After finalizing the numbers the two committees present the board of directors with their figures for approval.

Form 990, Part VI, Section C, Line 19: Policies, governing documents and financial reports are given to the public upon request. If they would like to stop by our offices we will provide them a copy and even spend time answering questions they may have. We will also mail copies to the public, only after receipt of reimbursement of actual costs to produce and mail are received.

There has been no change since the previous year in how the organization chooses the independent accountant performing the audit of the organization's financial statements.
