Collections are antiques, works of art, and other items of historic significance that have been donated to The Association. The Association then places these items in historic properties/ museums in Alexandria, Va. Some of these items remain the property of The Association and are on loan to a particular museum. Other items are donated to the museums with the stipulation that, if the museum no longer needs the item, the item must be returned to The Association for sale or donation to another museum. The number of items in collections that still belong to the Association is 27 at an estimated value of \$40,550. Since many of these items are not valued at this time, the amount of the collections is left blank.

The Association conservator maintains records on the collections and is required to annually inspect the museums where the collections are placed to ensure that the collections items are present and have not been abused.
