**WHEREAS**, a body politic and corporate by the name of Covington Protestant Children's Home was created by an act of the Kentucky General Assembly of the Commonwealth of Kentucky on April 13, 1880, and

**WHEREAS**, Article 11 of the Charter of said Covington Protestant Children's Home was amended by an act of said General Assembly on February 27, 1882; and,

**WHEREAS**, the Constitution of The Commonwealth of Kentucky was earlier amended on September 28, 1891 to establish the office of the Kentucky Secretary of State; and,

**WHEREAS**, said amendment to the Kentucky Constitution provided; *inter alia*, that all corporations in existence in Kentucky on the date of September 28, 1891 were required to file an acceptance of the provisions of the 1891 Constitution with the Kentucky Secretary of State by September 28, 1897 or their charter would be repealed; and,

**WHEREAS**, said Covington Protestant Children's Home failed to file the necessary acceptance with the Secretary of State; and,

**WHEREAS**, Covington Protestant Children's Home desires to change its name to Children's Home of Northern Kentucky, Inc., and to replace the Original Charter of Covington Protestant Children's Home and all Amendments thereto with these Amended and Restated Articles of Incorporation;

**NOW THEREFORE BE IT KNOWN TO ALL PERSONS BY THESE PRESENTS:** On April 16, 2013 a meeting of the Board of Directors of Covington Protestant Children's Home was called to order. Roll was called; a quorum of the members was present. A vote was taken pursuant to the provisions of Kentucky Revised Statutes §273.267 to amend the articles of incorporation and at least two-thirds (2/3) of the votes which were cast by those entitled to vote approved the adoption of the following Amended and Restated Articles of

Incorporation under the provisions of KRS §273.100, et seq., and §501 (c)(3) of the Internal Revenue Code of the United States, as amended, (the "Code") as follows:

### **ARTICLE I: NAME OF CORPORATION**

The name of the corporation is hereby changed to Children's Home of Northern Kentucky, Inc. ("The Corporation") and as such shall constitute a Kentucky nonprofit, non-stock corporation, with perpetual succession, and shall have power to sue and be sued, to contract and be contracted with, to adopt a corporate seal, and to conduct and operate its business and affairs.

### **ARTICLE II: ADDRESS**

The principal office of said corporation is located at 200 Home Road, Covington, KY 41011.

### **ARTICLE III: PURPOSES**

The objects and purposes of The Corporation, and the powers it shall have and may exercise, are as more fully set forth in KRS §273.171, as may hereafter from time to time be amended, including the following:

- (a) To provide children and families with opportunity and hope for better lives by offering treatment programs for children and youth between the ages of 7 and 17.
- (b) Conducting the work of the corporation not for profit, but exclusively for charitable, scientific, literary, religious or educational purposes within the meaning of Section 501 (c) (3) of the Code in such manner (i) that no part of its income or property shall inure to the private benefit of any donor, director or individual having a personal or private interest in the activities of the Corporation, except as reasonable compensation for services actually rendered, (ii) that it shall not directly or indirectly participate in or intervene in any political campaign on behalf of any candidate for public office, and (iii) that no substantial part of its activities shall be carrying on propaganda or otherwise attempting to influence legislation; and that it may make, if desired, distributions to organizations which qualify as tax exempt organizations as defined by Section 501 (c)(3) of the Code in addition to the charitable donations of its intended ministry.

(c) Acquiring, owning and maintaining real estate, buildings, gifts, bequests and funds, and all other property, real or personal as it may desire.

(d) To engage in other activities, projects and business permitted by the laws of Kentucky for a non-stock, non-profit corporation.

#### **ARTICLE IV: GOVERNING BOARD/TRUSTEES**

1. **Board of Trustees.** Pursuant to the provisions of KRS 273.163 (7) of the Kentucky Revised Statutes, the supervision, management and control of the business and affairs of The Corporation shall be vested in a governing board which will be known as the Board of Trustees. Said Board of Trustees shall exercise The Corporation's power and authority as provided by its Bylaws. The Board of Trustees shall consist of no less than fifteen (15) but no more than eighteen (18) persons; the number, term, manner of election and the filling of vacancies of which shall be as provided for by the Corporation's Bylaws.

2. **Vacancies.** Vacancies on the Board of Trustees shall be filled as provided by the Bylaws of the Corporation.

3. **Limitation of Liability.** Neither the Trustees nor the officers of this Corporation, its agents, employees and those acting at its request, nor any subsidiary, affiliated or supporting organization of The Corporation or its successors or assigns shall be liable for the debts, liabilities or obligations of this Corporation, and the private property of such persons, organizations and agencies shall not be subject to the payment of corporate debts. The provisions of KRS § 411.200, KRS § 273.248 and KRS § 273.171(14), and any future amendments thereto and any successor enactments, are adopted to the fullest extent permitted.

The Board of Trustees shall be authorized to obtain, maintain in effect, and pay for insurance to provide coverage for legal liabilities, legal defense fees, and expenses of its officers, Trustees, committee members, agents, and employees of the Corporation against whom claims have been made for losses, damages and judgments arising out of actions taken by said persons while acting with their scope of authority as an officer, Trustee, committee member, agent or employee of the Corporation, and to indemnify and hold same harmless.

#### **ARTICLE V: MEMBERS**

The members of the Corporation shall be the current Board of Trustees of Covington Protestant Children's Home, now known as Children's Home of Northern Kentucky, Inc., and

their successors in office for their appointed terms. There shall be no stockholders in this corporation.

#### **ARTICLE VI: DISSOLUTION**

In the event of a dissolution of the corporation, the Trustees of the Corporation shall, after making provisions for the payment of the liabilities of the corporation, dispose of all of the assets of the corporation as directed by its By-Laws in a manner consistent with the provisions of the Kentucky Revised Statutes.

Any assets not disposed of in accordance with the above direction shall be disposed of by a court of competent jurisdiction in which the principal office of the corporation is then located for all such purposes as shall at the time qualify as an exempt organization under § 501(c)(3) of the Internal Revenue Code of 1986, as amended.

#### **ARTICLE VII: BYLAWS**

Bylaws of the Corporation may be adopted or amended by the Trustees at any regular meeting or at any special meeting called for that purpose. The Board of Trustees shall operate at all times within the operational framework of the Corporation as provided by its Bylaws so long as those By Laws are in conformity with the Kentucky Revised Statutes, or other federal, state or local laws. In the event of conflict with the bylaws and the Kentucky Revised Statutes or other federal, state or local laws, said statutes or laws shall prevail.

#### **ARTICLE VIII: AMENDMENTS**

These Articles may be amended pursuant to the By-laws of the Corporation and further to the provisions KRS § 273.263 and KRS § 273.267 as currently exist, and as each may be hereafter modified or amended from time to time.

#### **ARTICLE IX: CONTRACTS**

Any required contract, deed, bill of sale, mortgage, or other written instrument necessary to carry out action authorized by the Board of Trustees of the corporation shall be executed in the name of the corporation and signed by its President and any other one officer; and, any instrument so executed shall be binding and effective as the action of the corporation.

**ARTICLE X: MEETINGS**

All meetings of the Board of Trustees and its committees; meeting notices, committee assignments, change in number of Trustees, and provisions for the sale of the Corporation's real and personal property shall be pursuant to the provisions of the Corporation's Bylaws.



**ARTICLE XI: ADOPTION**




