THE GROUP BEGAN MEETING DURING THEIR LUNCH HOUR TO ORGANIZE FOOD SALES AND OTHER SMALL FUND-RAISERS TO RAISE MONEY TO HELP THEIR CLIENTS MEET THESE NEEDS. VIRTUALLY ALL OF THE MONEY RAISED BY ANOTHER WAY GOES DIRECTLY TO HELP CLIENTS.
