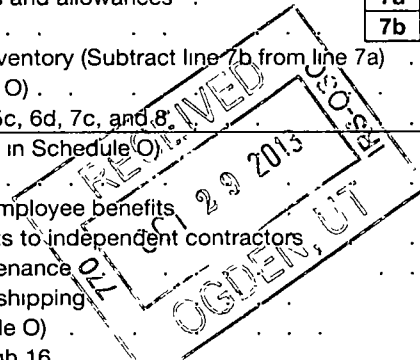

World Citizens promotes the following outstanding programs: Peace Education Networking Sessions, International Peace Sites, an online course for credit through Hamline University, and supports Augsburg College in providing opportunities for youth at the Nobel Peace Prize Forum. These programs focus on empowering the education community to promote a just and peaceful world. The Peace Education Program continues to expand by 20-25 participants a year. Since the beginning of this program, 261 educators from 100 schools and 1 church have participated in the World Citizen Peace Education Programs since 2003. During the 11 years of Peace Education opportunities, more than 66,000 students have been positively impacted by what educators bring back to their school and church communities. Six trained facilitators assumed the full time leadership role for all sessions in 2012-2013 as well as facilitating the online course. The International Peace Site Program continues to grow each year. World Citizens has supported many new Peace Sites as well as those who have rededicated this past year. New sites and re-dedications include schools, homes and many other places of business, government and worship. There are more than 200 Peace Sites in Minnesota and approximately 4,505 worldwide. This past year Augsburg College provided opportunities for over a thousand youth to participate in the Nobel Peace Prize Forum. Displays, musical performances and lectures are a few ways in which youth can learn about Nobel Peace Prize Laureates. Many website upgrades made this past year will accommodate worldwide contact and sharing while increasing social network capabilities. This continues to provide the opportunity for contact with more individuals and organizations who share the same passion as World Citizen for a Just and Peaceful World.
