Six (6) grants in the amount of \$700 each for a total of \$4,200 were awarded to coaches to attend a national clinic or seminar. Assistance in the amount of \$11,000 total was given to twenty (20) coaches to attend a national clinic. The organizations all contribute to the exempt purpose of the organization. The organization also provides coaches across the state a clinic to better themselves for the benefit of students they coach.
