Performances The Kronos Quartet tours for 22 weeks each year, performing in the United States and abroad Performances take place in concert halls, universities, outdoor stages, festivals, and clubs, including Carnegie Hall, Sydney Opera House, Monterey Jazz Festival, Barbican in London, Shanghai Concert Hall, Edinburgh International Festival, Toronto's Luminato Festival, Teatro Colon in Buenos Aires, and hundreds of others In the summer of 2013, Kronos co-curated and performed in a full week of concerts in New York's prestigious Lincoln Center Out of Doors festival Kronos also performs regularly in the San Francisco Bay Area and Northern California, with appearances at San Francisco's Yerba Buena Center for the Arts, UC Berkeley and Stanford University, and the outdoor Stern Grove Festival, among others

Commissions and Projects The Kronos Performing Arts Association (KPAA) has commissioned more than 800 new works and arrangements for the Kronos Quartet since the group's founding Kronos performs these pieces in concerts throughout the world, and many of the works have been recorded and disseminated on CD, radio, television, and the Internet Hundreds of the works commissioned by Kronos have been performed by other musicians and used in dance, theater, television, and film productions In addition to commissioning musical works, Kronos produces staged works on an ongoing basis Recent productions include "Sun Rings," "Awakening," "A Chinese Home," and "Music From 4 Fences "

Mentoring/Education The Kronos Quartet participates in mentoring and education projects on an ongoing basis In 2003, to celebrate the 30th anniversary of the group, KPAA initiated the "Kronos Under 30" project, a mentoring and residency program for composers under the age of 30 The group participates in many residencies at universities each year, working with student composers, musicians, and students from other areas of study In 2007 and 2009 the quartet participated in Professional Training Workshops at Carnegie Hall's Weill Institute, which involved intensive coaching with young professional string quartets Kronos often performs for school-aged children and families, both in schools and in concert hall settings KPAA management also advises other organizations, performers, composers, and arts professionals on an ongoing basis
