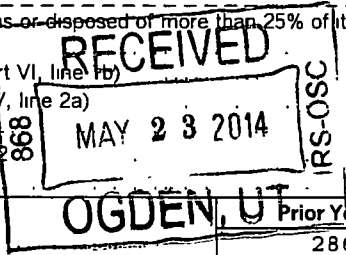

The Museum offers interactive, educational exhibits to more than 35,000 attendees annually, and strives to keep the gallery floors dynamic with new and exciting experiences. This year the Museum opened the Ronald McDonald House Charities Creativity Center, an entire renovated level of the museum dedicated to exhibits and activities that engage creativity and artistic expression. New exhibits in the Center include a touch-screen Art Machine, a magnetic canvas wall, and a fabric weaving wall. The Museum's stairwell was transitioned into a three-story mural exhibit, complete with educational interactives. Also, this year, the Museum opened a new exhibit titled "How Erie Water Works" which invites visitors to explore the process of providing clean drinking water to the region. The museum enhances the exhibit experience with dynamic programming, regularly offering new educational and creative activities like movement and dance, seasonal arts and crafts, literary activities in the Creativity Center, creative paper making, story times, etc.
