

AmeriCorps* VISTA (Volunteers in Service to America) provides full-time members to nonprofit, faith-based and other community organizations, and public agencies to create and expand programs that ultimately bring low-income individuals and communities out of poverty. The Pennsylvania Campus Compact program is based on college/university campuses and dedicated to the elimination of poverty by developing campus-community partnerships, mobilizing volunteers to serve their communities, and raising funds to sustain long-term programming. PACC*VISTA members work in the areas of K-12 academic achievement, college access, and food access. In 2012-2013 PACC*VISTA members mobilized 1,876 student and community volunteers, who in turn provided 26,971 hours of voluntary service

AmeriCorps Community Fellows-The purpose of the AmeriCorps Community Fellows program is to address compelling community needs in the areas of college readiness, access and success, while developing college students to be active citizens. In exchange for committing to serving 300 or 450 hours over the course of the calendar year, Community Fellows receive an AmeriCorps Education Award of \$ 1,175 or \$ 1,468 upon completion of their service. Through the 2012-2013 AmeriCorps Community Fellow Program, 382 college students served in minimum-time positions (300 hour positions) and 18 college students serviced in quarter-time positions (450 hour positions). Through these projects; 2,717 at-risk high school students showed and increased interest in attending college; 2,082 at-risk
