Part V (2)(d)(3) -- This amount represents balance due to The Vista Foundation resulting from the Foundation funding a portion of the School's operating expenses during the fiscal year ending June 30, 2013 and prior years.

Part V (2)(d)(4) -- The Vista School paid a Management Fee to the Foundation in the amount indicated to reimburse the Foundation for certain administrative and managerial functions performed by Foundation employees in support of operations of the School pursuant to the Management Agreement between The Vista School and The Vista Foundation dated July 1, 2005.
