AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
THE SYMPHONY FUND

(Formerly, Colorado Symphony Endowment Fund)

Pursuant to section 7-130-106, Colorado Revised Statutes (C.R.S.), the board of directors of the corporation hereby amends and restates the articles of incorporation of Colorado Symphony Endowment Fund in their entirety as follows:

ARTICLE 1.

NAME

The name of the corporation is The Symphony Fund.

ARTICLE 2.

DURATION

The corporation shall have perpetual existence.

ARTICLE 3.

PURPOSES AND POWERS

Section 3.1 Purposes. The corporation is organized and shall be operated exclusively for charitable, educational, scientific and literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provisions of any subsequent federal tax laws). Subject to the foregoing, the specific purposes and objectives of the corporation are as follows:

(a) This corporation is organized exclusively to support and carry out certain charitable, educational and scientific purposes of the Colorado Symphony Association within the meaning of Section 501(c)(3) of the Internal Revenue Code, and in this connection, subject to the

restrictions set forth below, the objects and purposes of the corporation and the nature of the business to be carried on by it are to promote and fund the charitable and educational endeavors of the Colorado Symphony Association now located in Denver, Colorado, and to help finance certain of the costs of operating the Colorado Symphony Orchestra.

(b) This corporation may not benefit any organization other than the Colorado Symphony Association so long as the Colorado Symphony Association remains in existence and operates the Colorado Symphony Orchestra or a substitute symphony orchestra. If the Colorado Symphony Association suspends its operations for longer than two full orchestra seasons, the board of directors shall determine, by a vote of two-thirds of the directors then in office, whether the original objects and purposes of the corporation can be achieved. Upon a determination that such original objects and purposes cannot be achieved, or if the Colorado Symphony Association ceases to exist, this corporation may benefit a substitute symphony organization or musical enterprise determined by agreement between this corporation and its donors, or in the absence of such agreement, by the board of directors but in each case that qualifies as a tax exempt entity under Section 501(c)(3) of the Internal Revenue Code whether located within or without of the State of Colorado.

Section 3.2 Powers. In furtherance of the foregoing purposes and objectives (but not otherwise) and subject to the restrictions set forth in Section 3.3, the corporation shall have and may exercise all of the powers now or hereafter conferred upon nonprofit corporations organized under the laws of Colorado and may do everything necessary or convenient for the accomplishment of any of the corporate purposes, either alone or in connection with other organizations, entities or individuals, and either as principal or agent, subject to such limitations as are or may be prescribed by law.

Section 3.3 Restrictions On Powers.

(a) The corporation shall not have or exercise any power or authority either expressly, by interpretation, or by operation of law, nor shall it directly or indirectly engage in any activity that would prevent it from qualifying (and continuing to qualify) as a corporation described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provisions of any subsequent federal tax laws).

(b) No part of the net earnings or assets of the corporation shall inure to the benefit of or be distributable to any incorporator, director or officer of the corporation or any other individual (except that reasonable compensation may be paid for services rendered to or for the benefit of the corporation affecting one or more of its purposes and to make reimbursement in reasonable amounts for expenses actually incurred in carrying out its exempt purposes), and no director or officer of the corporation or any other individual shall be entitled to share in any distribution of any of the corporate assets on dissolution of the corporation or otherwise.

(c) No substantial part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation. However, if the corporation is an organization to which section 501(h) of the Internal Revenue Code applies and the corporation has effectively elected to have such section apply, the corporation shall have power to carry on the activities permitted by such section, but only to the extent such activities shall not result in the denial of exemption under such section. The corporation shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(d) Upon dissolution of the corporation, all of the corporation's assets remaining after payment of or provision for all of its liabilities shall be paid over or transferred to, to and among one or more exempt organizations described in section 501(c)(3) of the Internal

Revenue Code, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, in such shares and interests, as shall be determined by the board of directors.

(e) Notwithstanding any other provision of these articles of incorporation, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax as an organization described in section 501(c)(3) of the Internal Revenue Code, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

(f) All references in these articles of incorporation to provisions of the Internal Revenue Code are to the provisions of the Internal Revenue Code of 1986, as amended, and to the corresponding provisions of any subsequent federal tax laws.

ARTICLE 4.

OFFICES

Section 4.1 Principal Office. The address of the initial principal office of the corporation is Boettcher Concert Hall, 1000 14th St, # 15, Denver, Colorado 80202.

Section 4.2 Registered Office and Agent. The street address of the initial registered office of the corporation is Boettcher Concert Hall, 1000 14th St, # 15, Denver, Colorado 80202. The corporation shall initially act as its own registered agent.

ARTICLE 5.

MEMBERS

The corporation shall have no voting or nonvoting members. The corporation shall have no capital stock.

ARTICLE 6.

BOARD OF DIRECTORS

Section 6.1 General. The management of the affairs of the corporation shall be vested in a board of directors, except as otherwise provided in the Colorado Revised Nonprofit Corporation Act, these articles of incorporation or the bylaws of the corporation. The number of directors, their classifications, if any, their terms of office and the manner of their election or appointment shall be as provided from time to time in the bylaws of the corporation.

Section 6.2 Liability of Directors. No director shall be personally liable to the corporation for monetary damages for breach of fiduciary duty as a director, except that the foregoing shall not eliminate or limit liability of a director to the corporation for monetary damages for the following: (a) any breach of the director's duty of loyalty to the corporation, (b) acts of omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (c) acts specified in C.R.S. Section 7-128-403 (prohibiting unlawful distributions) or C.R.S. Section 7-128-501(2) (prohibiting the making of loans to officers or directors of the corporation), as they now exist or hereafter may be amended, or (d) any transaction from which the director directly or indirectly derived an improper personal benefit. If the Colorado Revised Nonprofit Corporation Act hereafter is amended to authorize the further elimination or limitation of the liability of directors, then the liability of a director of the corporation, in addition to the limitation on personal liability provided herein, shall be further eliminated or limited to the fullest extent permitted by the Colorado Revised Nonprofit Corporation Act. Any repeal or modification of this Section 6.2 shall be prospective only and shall not adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification.

Section 6.3 Board. Except as may otherwise be provided in the bylaws, the incumbent board of directors shall continue in office until their successors shall have been duly elected and qualified.

ARTICLE 7.

BYLAWS

Except to the extent limited by the Colorado Revised Nonprofit Corporation Act, the board of directors shall have power to alter, amend or repeal the bylaws from time to time in force and adopt new bylaws. Notwithstanding the foregoing, the bylaws of the corporation may not be amended without the approval in writing of board of trustees of the Colorado Symphony Association. The bylaws of the corporation may contain any provisions for the managing and regulating of the affairs of the corporation that are not inconsistent with law or these articles of incorporation, as these articles may from time to time be amended. However, no bylaw shall have the effect of giving any director or officer of the corporation or any other individual any proprietary interest in the corporation's property, whether during the term of the corporation's existence or as an incident to its dissolution.

ARTICLE 8.

AMENDMENTS

The board of directors shall have the exclusive power and authority at any time and from time to time to amend these articles of incorporation by the vote of a majority of the directors then in office.
