In the past The Knights Academy prepared its IRS990 Return on the accrual basis of accounting. However the books of original entry are kept on the cash basis of accounting during the fiscal year. The entity is audited but the audit is usually performed after the tax return is due (November 15th) and the audited financial statements are on the accural basis of accounting.

A prior year adjustment was made in the amount of \$48320 to eliminate last years accruals and convert back to the cash basis.
