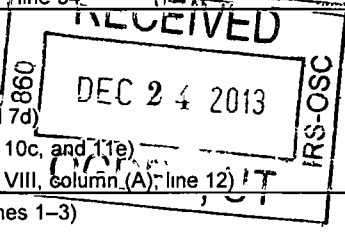

Summary of Program Accomplishments

July 2012-June 2013

- Presented 50 Bridge Sessions to approximately 4,300 participants, including school-age students and special needs populations, from 40 different schools and organizations. 95% attended for free and the rest attended at subsidized ticket prices. Sessions took place at World Cafe Live in Philadelphia, PA, and World Cafe Live at the Queen in Wilmington, DE.
 - Continued our partnership with The Philadelphia Orchestra's School Partnership Program to present 10 sessions and commission 4 new Bridge Session programs. The programs link classical music to other genres and feature collaborations of LiveConnections and Orchestra teaching artists and musicians.
 - Continued our partnership with the Light Up the Queen Foundation to present 12 sessions in Wilmington, Delaware.
 - Partnered with Arab cultural organization Al-Bustan Seeds of Culture to present 5 sessions featuring prominent Arab artists from the Middle East.
 - Partnered with radio station WXPN to present a session with the Homemade Jamz Blues Band, a band of high school-age musicians, as part of WXPN's Mississippi Blues Project.
 - Expanded outreach to schools, with 15 schools attending Bridge Sessions for the first time.
 - Expanded the number of partner schools from 2 to 6, including high schools Freire Charter School and Science Leadership Academy and middle/elementary schools Christopher Columbus Charter School, Greenfield Elementary School, J.S. Jenks School and People for People Charter School. Each of these schools attended a sequence of 3 sessions throughout the school year, bringing the same group of students each time for a cumulative experience.
 - Presented 2 sessions geared for adults with cognitive disabilities, who attended in partnership with Art-Reach. Began talks with Art-Reach to expand the partnership in the 2013-2014 season.
 - Developed online curriculum materials for our three percussion-themed Bridge Session programs. The materials offer listening samples and activities that teachers may use before or after a Bridge Session to connect the themes back to their own classrooms.
 - 37 musicians from diverse genres—including classical, jazz, blues, rock & roll, Latin, West African and Arab—presented Bridge Sessions.
- Presented 7 ClassicAlive concerts, aiming to expand the boundaries of classical music through repertoire, collaboration and atmosphere. One of the concerts took place at World Cafe Live at the Queen in Wilmington and the other 6 took place at World Cafe Live, Philadelphia. A total of 800 people attended. Additionally presented an opening act for a World Cafe Live at the Queen performance to help build a broader audience base in Wilmington.
 - The season focused on cross-genre collaborations between classical and non-classical artists. LiveConnections' ClassicAlive curator Mary Javian initiated the partnerships and worked with the artists to craft the programs and select repertoire.
 - Participating artists included OneBeat; The Laughing Bird; Jen Creed and Svetlana Smolina; IVA and Tripod Trio; PROJECT Trio and Friends Select Ensemble; Play On,

- Philly! and Philadelphia Dance Academy; Mélomanie and Minas; and “Crossing Strings” with David Ludwig, Jason Vieaux, Hanna Khoury and Hafez Kotain.
 - LiveConnections commissioned its first work, an Arab suite for guitar and violin, by composer David Ludwig. The resulting work, “Kantigas,” blends Sephardic and classical sounds. It premiered on June 7, 2013, at World Cafe Live, Philadelphia.
 - The “Crossing Strings” project, featuring the above-mentioned commission, included a Bridge Session component, where the artists presented an interactive performance for elementary school students on June 6, 2013.
 - The “Crossing Strings” project was also the first ClassicAlive event streamed live online through our new LiveStudio video initiative.
 - Several student ensembles performed on the season, including the Friends Select Ensemble and percussion troupe, a small ensemble of students from Play On, Philly!’s orchestra training program and ballet dancers from the Philadelphia Dance Academy. Students from Play On, Philly! and the Philadelphia Dance Academy also had an opportunity to perform for their peers at a “Rhythmic Body” Bridge Session in May 2013.
 - Several of the partnerships initiated by LiveConnections for this concert series have resulted in ongoing collaborations between the artists.
- Completed installation of the LiveStudio video system (formerly Collaborative Connections) in the Downstairs Live space of World Cafe Live, Philadelphia, in the winter of 2013. Began test runs in the spring of 2013. The system allows us to live-stream performances for viewing on computers or mobile devices.
 - Streamed the “Crossing Strings” ClassicAlive concert on June 7, 2013. The artists were highly impressed by the quality of the footage.
 - Streamed several Free at Noon concerts in partnership with radio station WXPB.
 - Began conversations with Art-Reach to lay the groundwork for streaming Bridge Sessions in the 2013-2014 season to special needs populations who cannot travel to the venue.
 - In May 2013, completed our second annual Kids Count Campaign—an online crowdfunding campaign—to support Bridge Sessions. An email blast was sent each day for 8 days to share stories about Bridge Sessions. The campaign raised more than \$19,000 from 130 donors. Nearly half of the donors were new contributors to LiveConnections.
 - Kicked off LiveConnections’ 5th anniversary celebrations, which began in May with our official anniversary date (May 15, 2008), and will continue with a 5th anniversary gala in October 2013.

Facts and Circumstances Test – Schedule A, Part II

LiveConnections (LCO) is a music-presenting and educational organization committed to reaching new and underserved audiences across the Philadelphia, PA, and Wilmington, DE, region. LCO qualifies as publicly supported because it meets the 10% plus facts and circumstances test under Tres. Reg. 1.1709A-9(e)(3) in the following respects:

10% of Support Limitation

LCO's public support fraction of 21.68% meets the 10% threshold.

Public Participation in Programs

LCO engages in a mission of educational activities and music performances that are conducted directly for the benefit of the public on a continuing basis. One of LCO's primary mission objectives is to remove barriers that prevent audiences from experiencing high-quality music performances. LCO presents educational music performances for free for public schools, independent schools and special needs organizations in the Philadelphia, PA, and Wilmington, DE, region, reaching many schools unable to afford in-school music programs. LCO also presents public concerts for general audiences at affordable ticket prices and provides live web-streaming of many of its programs for underserved populations who are unable to travel to the venue.

In its first five years, LCO has reached more than 14,000 school students and people with special needs through 160 educational performances, as well as 1,700 adult audiences through more than 20 public concerts. LCO's programs are promoted to the public through its website, social media, email blasts and advertising in print, web and radio. LCO continues to expand its base of program recipients and has shown growth in programming, attendance and participation each year since its founding.

Representative Governing Body

LCO's activities are governed by a board of directors, reflecting a broad range of individuals with background and expertise in managing and operating a nonprofit organization. LCO's governing body includes individuals with experience in the area of law, business, finance, fundraising, music presenting and education. Board members have served or currently serve on the governing bodies of numerous arts and social services non-profit organizations across the region. An ongoing goal for board development is to achieve greater gender, racial and professional diversity as well as to attract and engage board members willing to significantly contribute to LCO's fundraising efforts.

LCO currently has 13 board members. Each board member supports LCO financially and they engage in efforts to solicit funds from other sources for LCO. Recent fundraising campaigns, including an online campaign and an anniversary gala, have been heavily driven by board efforts to solicit donations from their extended networks of colleagues and friends. In addition, board members' relationships to foundations have allowed LCO to seek new and increased foundation support.

Sources of Support

LCO's funding comes from diverse sources of support, including private foundations, corporations, organizations and individuals who support its mission and programs. LCO regularly writes grants and submits proposals to foundations, and efforts have resulted in new funding relationships. LCO also frequently partners with other arts nonprofits in soliciting funds for collaborative projects. LCO has developed a sponsorship program to better solicit funds from corporations.

LiveConnections

Attraction of Public Support

LCO is organized and operated to attract new and additional public support on a continuous basis.

During its two most recent fiscal years, LCO has engaged in an annual online giving campaign which has increased public awareness of LCO, broadened its base of individual donors and generated numerous contributions from new donors. From the first year to the second year, the campaign saw 230% growth in donations (from \$8,390 to \$19,289) and 190% growth in the number of donors (from 68 to 130).

In the last two fiscal years, LCO has also received new and increased foundation support. The Charter Foundation gave for the first time in FY2013, the Lomax Family Foundation doubled its annual contribution in FY2013 and the Scholler Foundation has pledged a first-time gift of \$15,000 for FY2014. LCO continues to solicit funds from prospective contributors on a regular basis, with current grant requests out to the Philadelphia Cultural Fund, PNC Arts Alive and Presser Foundation and upcoming proposals being prepared for the Fels Fund and Picasso Project.

In October 2013, LCO held a 5th anniversary fundraising event which generated significant new and expanded revenue, with gross income totaling over \$64,000. LCO gained 20 new corporate sponsors for the 5th anniversary season and sold out the event with more than 300 RSVPs. LCO will continue to cultivate those corporate and individual donors over the coming year and solicit additional donations.

LCO sends out regular solicitations via email and social media to its base of supporters and includes requests for support on all concert programs.

LCO has received favorable public attention in the media for its programs, which it believes will allow it to attract additional new sources of public support.

Prior to November 2011, all fundraising efforts for LCO were managed exclusively by the board. The addition of a full-time General Manager in 2011 has significantly increased LCO's fundraising capacity over the last two years. To further increase capacity, LCO plans to hire a Director of Development in the winter of 2014 whose role will be to solicit new donations from individual, foundations and corporations and to increase donations from the existing donor base.
