Orphan's Tree, Inc. is dedicated to bringing the benefits of family and God's hope to Russian orphans when they are most alone.

Orphan's Tree, Inc. is committed to supporting programs that will have the greatest influence in the lives of older orphans and at-risk kids in today's Russia. There are current challenges that we target as we participate in providing solutions for the benefit of at-risk kids with two NGOs (non-governmental organizations) – Nadezhda Fund and Together Fund.

Orphan's Tree is a U.S. partner of the Nadezhda Fund, a Russian based NGO doing charitable work with orphans in Russia. Orphan's Tree works with the Nadezhda Fund in Moscow, Vladimir, Ivanovo and Kostroma regions.

Orphan's Tree also supports a second NGO in Russia, Together Fund. The Together Fund is doing work with young adult orphans in Kostroma, St Petersburg and Vladimir regions. The Together Fund is partially funded by Orphan's Tree. The Together Fund operates under a shared board with Orphan's Tree and is consolidated in the financial statements. All material transactions and balances between the entities have been eliminated in the consolidation. These entities will be collectively referred to as Orphan's Tree.

There are three ways in which we provide program services to orphans in Russia:

1. We provide funds to provide salary support for Nadezhda Fund and together Fund employees and support activities, supplies and travel expenses for various programs.
2. We send U.S. volunteers to Russia to work with older orphans on the various Organization's programs, and
3. We develop and obtain grants from Russian corporations to support the Organization's programs facilitated by Nadezhda Fund and Together Fund.

Statement 2 – Form 990, Part III, line 4a – Statement of Program Service Accomplishments

Description

Ministry Programs: Expenses of \$360,756, including grants of \$57,317

We provide funds to support supplies and travel expenses for the various Organization programs described below. Included in these program costs are an allocated part of the Organization's staff compensation and operating expenses to achieve program objectives.

Leadership: Expenses of \$14,917, including grants of \$6,383

One of our objectives is to groom leadership and volunteering traits in young adult orphans. This development is done throughout all of our programs and specifically includes having young adult orphans revisit their home orphanages to discuss their experiences after graduating from the orphanage and giving encouragement to other orphans. Other activities include volunteering at a local church, nursing homes and hosting Christmas parties for needy families.

Education: Expenses of \$79,621, including grants of \$9,128

Education takes place everywhere. As such, it overlaps with almost all programs. We desire to see orphans have doors opened for them through expanded educational opportunities. Typical examples of activities include appreciation seminars in art, music, and dance. We also fund nine older orphans studying in Moscow and St Petersburg. We provide support for living expenses and, in some cases, tuition.

Job Preparation: Expenses of \$18,927, including grants of \$5,505

Orphan's are becoming better educated, emotionally adjusted, and healthier citizens. However, a need exists for assistance in job preparation and their first career steps. The objective is to not simply be placed in a job, but to find fulfillment and satisfaction from their work. Studies have shown, however, that only a third of orphanage graduates find employment and then twenty percent of them lose it within the first year.

Responding to this critical need, Orphan's Tree offers internships at our Ministry Centers to equip the older orphans with job skills and allow them an opportunity to receive first-hand experience at a work place.

Life Skills: Expenses of \$61,524, including grants of \$23,313

Raised in an orphanage, orphans typically struggle with what many in society grow up understanding – basic life skills. As teens prepare to leave their orphanage, we desire to assist them in their transition to independent living in the outside world.

The ministry centers are drop-in centers where older orphans come for support, counseling, computer instruction, work out in the gym and receive counsel from our staff about their life and problems. We provide funds to support the activities held at the ministry centers that include training in basic life skills such as budgeting, interacting with teachers and others in authority, choosing good friends, being a good friend, elements of a healthy life style, and similar topics are offered. Training is provided in

seminar and small group settings. U.S. teams that are sponsored by the Organization provide this training. Funding covers staff salaries, materials and day trips for the older orphans.

Young Families: Expenses of \$18,891, including grants of \$3,798

In this fiscal year, we served 19 young families in the Vladimir, Kostroma and Ivanovo regions. Professional counseling and individual support and encouragement are key components of the Young Families program. We host a Mother's Day Out program which allows young mothers with respite care. There is also an emergency fund for unexpected illnesses or from a job loss.

Residential Care (Family Centers): Expenses of \$22,873, including grants of \$450

In this program, groups of both young men and women experience and learn from life in a family setting with a Russian couple. We provide partial support for three Lakinsk family centers. The remaining Lakinsk support comes from a grant, which we obtained from a Russian corporation (see Schedule O).

Dacha Project: Expenses of \$72,677, including grants of \$0

Going to a dacha in the summer is a strong part of the Russian culture. Dachas have vegetable gardens to raise food both for current use and for the coming winter months. Most important is the mentorship that transpires as staff members and young adult orphans work and recreate together. We provided funds for Together Fund to renovate the Kostroma dacha, more than doubling the space of the building enabling us to run additional future programs.

Orphans learn practical skills such as renovation of a building and how to maintain a garden. They also enjoy recreational activities such as fishing at a nearby river and cooking meals together.

Faith, Hope, Love: Expenses of \$19,744, including grants of \$408

The Faith, Hope, Love Program supports vulnerable young women in crisis situations. These young women are living in desperate poverty and are the most likely to be forced to place their children in an orphanage. This is a program effectively preventing destitute mothers from institutionalizing their children in an orphanage.

Flat renovation and other projects: Expenses of \$51,582, including grants of \$8,332

This program was designed to fill one of the most basic of needs for older orphans – housing.
