

The College Hill Foundation was formed and filed for non-profit status in 2008. The original board was attempting to purchase an abandoned school building but clear title was never presented to complete the purchase. After several attempts to complete plans to help restore the neighborhood the College Hill Foundation elected to a new set of Board of Directors with some of the previous members continuing to serve on the Board. This new Board was elected in 2012. The CHF continued to study how the CHF could be of use to the College Hill community. No significant activities occurred until the current fiscal year ending June 30, 2015.
