KNOM's mission is to inform, educate, inspire, and provide companionship for its listeners in remote Western Alaska.
KNOM's listeners (numbering close to 20,000 people) are spread across 100,000 square miles; most live in villages along the Bering Sea Coast and eastward toward the Alaskan Interior.

In early 2013, KNOM underwent a full financial audit of the FY12 accounts. The intent was to set a firm financial footing for the new nonprofit's transfer and operation of the 40-plus year old mission. FY12 included a quarter year of KNOM operations post-transfer. Results of the audit showed no material discrepancies.
Additionally, a formal internal controls policy draft was compiled based on current practices, including a few improvements thereof, suggested by the auditors. This policy will go before the board of directors for formal adoption in the fall, 2013.
In November 2013, FY13 accounts will undergo a full audit, this time for a full year of operation.

4b (Code: 86000) (Expenses \$ including grants of \$ 60,000) (Revenue \$ 196,630)
Construction began on the new digital studios expansion project. This capital improvement project will replace aging, outdated, slow and unrepairable equipment with modular, energy-efficient, wifi-ready digital equipment. As the TERRA Band (fiber optic network) makes its way North to Nome, KNOM is poised to take full advantage of greatly increased bandwidth capacity with digital production and broadcast equipment. Further, when fully functional, remote repair will be possible via a secure virtual network to diagnose and fix problems that may arise or be prevented.
All construction project expenses were capitalized to fixed assets.

In spring 2013 KNOM received the National Association of Broadcasters Heritage Award for service to community. This highly coveted award recognizes KNOM for its service to Western Alaska - including news, local programming, emphasis on Native culture, support for education, and availability for communication in times of weather-related distress.

The second, and much greater amount is donated contract volunteer time. The majority of KNOM's program service staff are five full-time workers who receive only room and board and a small monthly stipend. The amount listed above is the net amount after hourly wages are computed less the cost of their minimal compensation.
