Records of former Treasurer are insufficient here and do not list the details of one transaction, which was a \$70 deposit. At this point, this transaction is classified as a transaction in an unknown category.

The only other transaction classified in this category is a \$20.05 deposit, which is a return of the unused portion of a cash advance.

Form 990 EZ Part I Line 10 Grants

A total of \$4,115 in grants to teachers at Drew Model School were paid. Most grants were funded through a process involving a Teacher Grants Committee which reviewed the applications, consulted with the principal, and notified the applicants of their status. These grants funded a trip to the National Children's Museum (\$200), an interactive whiteboard for the art classroom (\$587), a culturally appropriate doll house and accessories (\$359), Montessori science materials on atoms (\$99), AMS conference attendance for a teacher (\$600), classroom materials for special education classroom (\$185), a field trip and materials for an art class (\$193), bilingual books for the ESOL/HILT classroom (\$264), and transportation for a field trip to the National Mall (\$428). An additional \$1200 funded teachers' choices of books for their classrooms at the annual school book fair. \$460 funded scholarships for fifth graders who needed financial help to attend \$460 funded scholarships for fifth graders who needed additional financial help to attend the annual overnight fifth grade field trip.

These expenses included field trip expenses (\$8,578), dues to the County Council (\$92), school gardening expenses (\$538), a Hispanic Heritage celebration (\$183), food for PTA meetings and coffee chats (\$1023), PTA liability, bonding, and directors and officers' insurance (\$458), Odyssey of the Mind (enrichment program) expenses (\$532), teacher/staff appreciation (\$1848), volunteer appreciation (\$200), national/state PTA dues (\$601), reception and gifts for graduating fifth graders (\$1073), banking and accounting charges (\$568), PTA supplies (\$109), PTA sound system (\$980), extended day end of year event (\$64), DVD for movie night (\$16), supplies for PTA art contest (\$75), Theme Theater expenses (\$34), and ice cream social expenses (\$56).
