Jazz Education - Two hundred one students participated in six nine-month musical ensembles, three multi-week combo workshops, and/or two two-week summer music programs specializing in performance for outreach communities and building leadership skills. The music programs included:
-Introductory ensemble twice a week Oct-May for 1.5hr per session for students with no musical experience
-Beginning Ensemble once a week Oct-May for 2hr for students with minimal musical experience
-Intermediate Ensemble once a week Oct-May for 2hr for students with moderate musical experience
-Two Advanced Ensembles each meeting once a week Oct-May for 2hr for students with more musical experience
-New Works Ensemble once a week Oct-May for 2hr for students with advanced musical experience looking for improvisation work
-Three 6-8 week Combo Workshops once a week Mar-May for 2hr for students looking for small group experience and improv work
-Summer Ambassadors Program 2 two-week/40hr sessions in July/Aug for students of all levels with a focus on performing for communities containing underserved children to expose them to jazz. This year we also offered leadership training for the older students in this program

Financial Support - provided tuition scholarship support for all families who requested help paying their student's program tuition. Thirty-seven percent (75 of 201) of students received some level of tuition reduction ranging from 15% to 100% of their total tuition fees. This resulted in waiving 25% of our total tuition fees for the year to guarantee that all students interested in participating in our program would have access, regardless of their ability to pay. We met our scholarship goals for the year

Jazz Performance & Outreach - Ensembles and smaller combos performed for the public as part of their education as well as to carry out our goal of exposing the community, especially youth, to jazz music in an effort to keep this art form alive. Performances were provided to the public, family & friends, donors, non-profit organization, community centers, and boys & girls clubs. Additionally, we held a free Girls Jazz Day clinic to expose more girls to becoming a jazz musician. Females are underrepresented participants of jazz programs in general.
