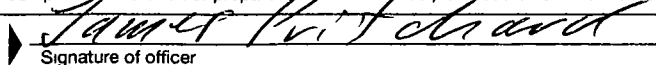

It does not at this time solicit or admit students but hopes to be able to do so soon, and in the meantime the College directs its energies towards fund-raising, which primarily involves sending representatives (typically its President Dr Stephen Blackwood) to meet with prospective donors and others who may be able to help the College meet its fund-raising goals wherever such persons may be located. This inevitably involves a certain degree of expense, especially with respect to travel, and the College's fund-raising costs typically include hotel rooms, meals, and airline tickets, as well as other travel costs, which is how the aforementioned \$50,597 primarily was spent.
