AIE - LA independently delivered 2 weeks to 21 students, and in collaboration with Louisiana State University (LSU) and University of Louisiana - Lafayette (UL) delivered an additional 2 weeks to 34 students, one week was delivered at LSU and the second at UL using AIE - LA course material and instructors. Summer Cyber Camp is geared toward high school students seeking knowledge in 3D programing and computer animation and is one week in length. These short courses promote school exposure to the community it serves and is an introduction to courses students will enjoy at the college level. Successful Summer Cyber Camps are important to the school's purpose and mission as they are often the first contact students have with the school and its staff.
