The foregoing amendment was adopted by a majority of the Board of Directors of the Corporation on June 19, 2013, and there are no members entitled to vote thereon.

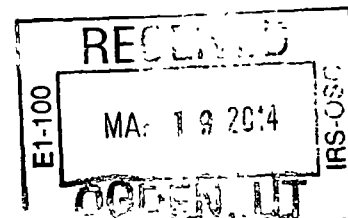

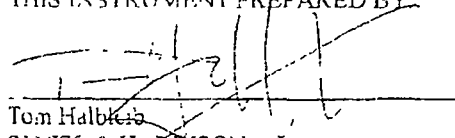
