Refinery Re-use store: Useable items diverted from trash loads and donated items are sold in a thrift store catering to low income individuals, artists, and 'do-it-yourself' craftsmen. Items include household goods, small appliances, furniture, electronics, tools, building materials and fixtures.

4b (Code:) (Expenses \$ 120,932 including grants of \$ 0.) (Revenue \$ 99,536)
Transfer station: CARTM holds the franchise for the North Tillamook County solid waste transfer station. Households and businesses deliver solid waste (trash). Patrons are encouraged to separate recyclable and reusable materials from trash at no charge, saving money on waste disposal and reducing the amount sent to the landfill.

4c (Code:) (Expenses \$ 108,080 including grants of \$ 0.) (Revenue \$ 120,877)
Recycling dropoff: Households and business bring paper, metals, plastics, cardboard, tires, glass and other recyclable materials. CARTM processes these materials and markets them to brokers or sells directly to mills for recycling.
Approximately 800 tons of recyclable material are diverted from the landfill through the CARTM facility each year.
